

# ELECTRONIC SIGNATURE NOTICE BEDROOM KANDI BOUTIQUE PARTIES - CONSULTANT E-AGREEMENT

#### Section I: Acceptance of the Agreement

Welcome to the Bedroom Kandi business. Please read the written Bedroom Kandi Consultant Agreement and the Policies and Procedures carefully, collectively referred to as the "Agreement."

## Section II: Enrollment and Monthly Admin Fee

At the time of your enrollment into the Bedroom Kandi business, you agree to submit a \$19 fee and purchase an introductory Consultant Kit as well as complete a variety of training materials. Please note that the payments associated with this fee and the Consultant Kit are NOT commissionable. You agree to a \$19 monthly admin fee to stay enrolled in the Bedroom Kandi program. These admin fees are also NOT commissionable. Cancellation requests will be effective in the calendar month in which Bedroom Kandi receives a notarized cancellation, but you can remove yourself from autopayments at any time in your BK Dashboard. If the notice to cancel is received after the debit has been processed, the cancellation will be effective in the following calendar month.

#### Section III: E-Sign Notice- Consent to Electronic Record

E-Sign, the *Electronic Signatures in Global and National Commerce Act* (15 U.S.C. § 7001, et seq.), requires that you consent to entering into an electronic agreement with Bedroom Kandi before a Consultant Agreement can be executed.

## Please read the following information carefully:

- If you enter into an online Consultant Agreement with Bedroom Kandi, you will not be required to submit a paper application. An electronic record will evidence the entire agreement between you and Bedroom Kandi. However, you must consent to the use of an electronic record and must read the Bedroom Kandi Terms of Use, the Bedroom Kandi Policies and Procedures, the Bedroom Kandi Privacy Notice, the Bedroom Kandi Compensation Plan, and electronically acknowledge below that you understand and have read these documents.
- To access these documents and submit your online Consultant Application, you will need a device with Internet access and an Internet browser.
  - By clicking on "I agree", you consent to the use of electronic records evidencing your agreement to the Bedroom Kandi Terms of Use, the Bedroom Kandi Policies and Procedures, the Bedroom Kandi Privacy Notice, and the Bedroom Kandi Compensation Plan of the Consultant Agreement.
